## ORDINANCE 2024-17 AN ORDINANCE FOR THE TOWN OF EDINBURGH 2025 BUDGET APPROPRIATIONS AND TAX RATE

Be it ordained/resolved by the Edinburgh Town Council that for the expenses of EDINBURGH CIVIL TOWN for the year ending December 31, 2025 the sums herein specified are hereby appropriated and ordered set apart out of the several funds herein named and for the purposes herein specified, subject to the laws governing the same.
